What is the eHealth Exchange?



The eHealth Exchange is a health data sharing network.

It is one of many that exist throughout the United States



But don't be fooled.
The eHealth Exchange is no ordinary network....



It provides a common set of standards, legal agreements and a governance framework that sets the groundwork for participants to securely share health data



How the eHealth Exchange is Different



The largest health data sharing network in the country



Only network allowing participants to connect directly with federal agencies



Unique technology framework connects organizations directly to each other with no central hub



These network differentiators allow the eHealth Exchange to deliver a unique value proposition to its participants.

eHealth Exchange Benefits Providers

Doctors have ready access to patient records from multiple facilities.



Reduced administrative burden to contact other medical facilities for records



Improved insight into effective treatment supports providers' ability to deliver quality care in line with CMS' pay for quality measures



More accurate picture of client's total health, aiding better diagnoses and treatment



Dramatically easier to submit medical records to federal agencies in support of claims for payment as well as to help patients support their own claims



Better customer service experience for provider's patients



Unique Data Sharing Framework

Because the eHealth Exchange is a "framework," it provides guidelines for organizations to connect directly to each other.

This means that:

- There is no central hub or data repository where data is vulnerable for hacking
- Organizations have tight control over their data
- An organization can ensure its data is properly protected per HIPAA laws





Summary of eHealth Exchange Approved Use Cases



Treatment / Care Coordination

Enables access to critical information (e.g., test results, medication history, allergy info, immunizations) and makes available to providers when patient is transferred



Responder Only Profile

Enables other networks (e.g., release of info, companies, and SAAS model vendors) to respond to queries from eHealth Exchange Participants on behalf of their client



Military/Veteran Health

DoD and VA exchange active service members and veterans' records to provide government and private caregivers with up-to-date medical histories



Authorized Release of Information – Disability Determination

Social Security Administration requests claimant records electronically to make disability determinations. Cuts down claims processes *from months to days*



Quality Reporting for the End Stage Renal Disease Program – CMS

Enables dialysis centers to send quality data to CMS to assure that individuals with End Stage Renal Disease receive the highest quality of care



Summary of eHealth Exchange Approved Use Cases (2)



Immunization

Enables the push of immunization data for treatment purposes (this is not related to immunization registries)



Authorized Release of Information – Consumer Access to Health Information Enables clinical exchange between patient and provider (e.g. via a Personal Health Record (PHR)



Encounter Alerts

Enables event notification of clinical encounters to patient associated care team members



Prescription Drug Monitoring Program (PDMP)

Enables exchange of PDMP data



Electronic Lab Reporting (in support of public health)

Enables electronic lab reporting to public health agencies



Syndromic Surveillance

Enables syndromic surveillance reporting to public health agencies



Summary of eHealth Exchange Approved Use Cases (3)



Authorized Release of Information – Life Insurance (Approved by CC on 12/7/16)

Enables life insurance companies to request copies of an individual's medical records for the purposes of making a determination for life insurance benefits



Image Share Use Case (Approved by CC on 11/15/16)

Enables organizations to share images via the eHealth Exchange.
