Input Request from US Core Data for Interoperability (USCDI) Task Force

- Review and provide feedback on the [Draft USCDI Version 2](#) content and process. The specific changes are:
 - Was the extent and scope of the proposed change appropriate?
 - Were the right data classes and elements added in the proposed new version?
 - Are any of the proposed additional data classes, elements or standards problematic?
 - Are there additional data classes or elements that have been categorized by ONC as Level 2 or even Level 1 that you believe should be added to USCDI V2?
- Do you have any comments on the USCDI expansion process?
 - ONDEC submission system improvements
 - Evaluation criteria and process used to assign levels to submitted data classes and elements
 - Prioritization process used by ONC to select new data classes and elements for Draft USCDI Versions

While eHealth Exchange encourages all stakeholders to submit formal public comments to ONC by the April 15 cut-off date, we would be very interested in [hearing your organization's early impressions of and/or concerns](#) regarding Version 2 so they can be provided to the HITAC task force to consider in their deliberations over the next three months.
