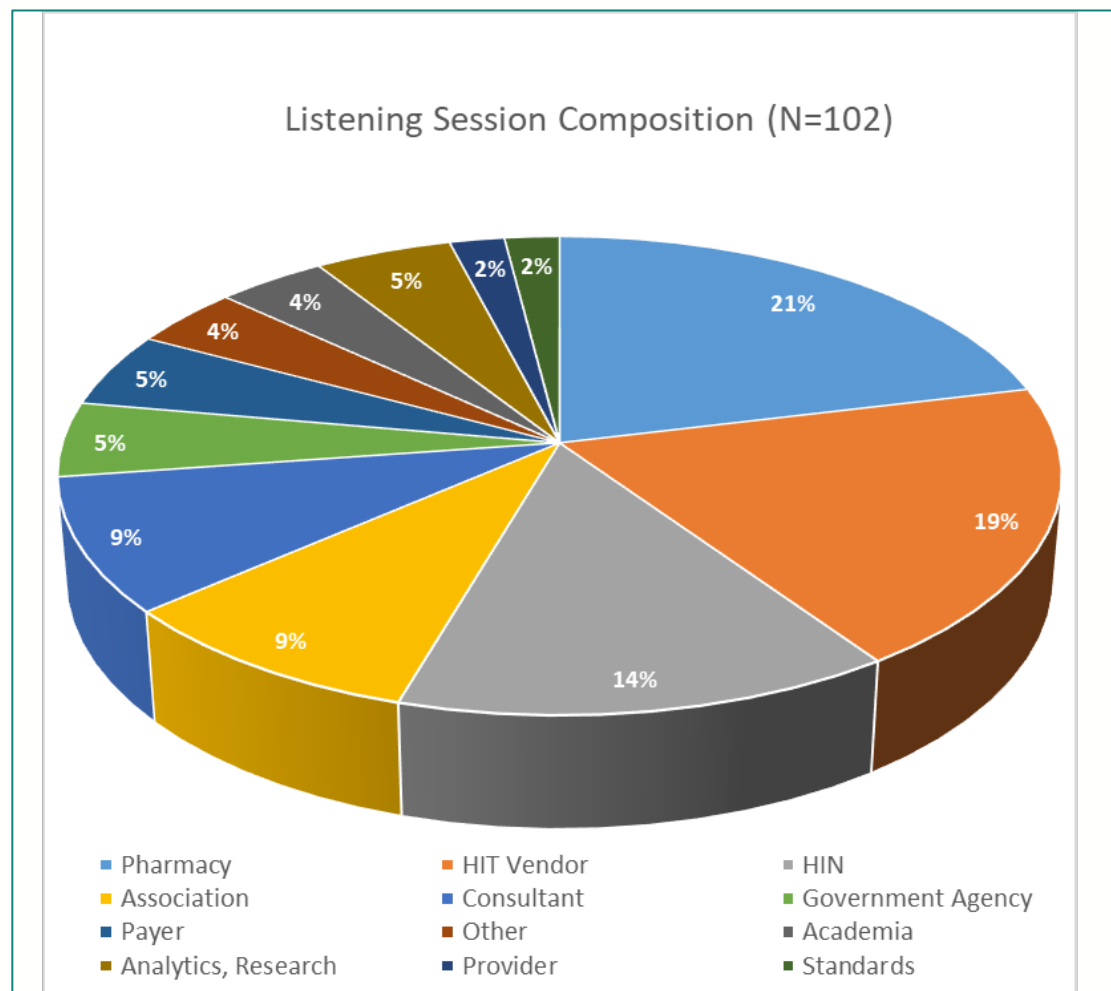

Listening Session Composition



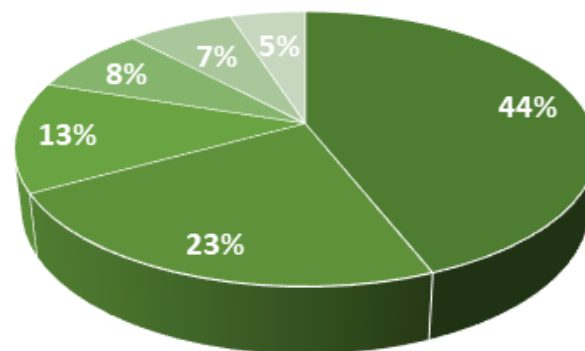

Why is Pharmacy Interoperability Important? (N=102)

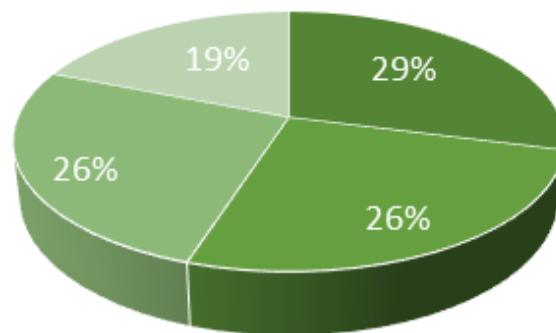


TOP 3 {

- Ensures information is shared across the care team
- Unlocks new opportunities for pharmacist-provided patient care, scalability
- Reduces administrative burdens
- Fuels public health efforts
- Facilitates reimbursement for care provided
- Increases patient safety; improves patient experience, health outcomes, access to care

Focus Areas

What are the **challenges** attendees want to overcome by advancing pharmacy interoperability?

- Access to **clinical information** to inform pharmacist patient care services
- Differences between the **technical environment** pharmacies operate within compared to the rest of the care team
- Need for multiple **integrations** to secure data and connect to all partners
- **Perception** amongst other providers that pharmacists don't need access to patient information.
- **Quality measure reporting** limitations pharmacists face when participating in value-based arrangements.

What are the specific **barriers** to including pharmacists in clinical information sharing today?

- The **financial investment** needed for new technology is a major barrier, fueled by lack of **reimbursement** for patient care services.
- Existing **pharmacy management system capabilities** and workflow.
- Inconsistent adoption of **standards** – not all pharmacy systems have the same capabilities for receiving and sending data.
- Lack of **EHR integration** – other providers have limited ability to access, use, and store data from pharmacists.
- **Slow uptake** of existing solutions amongst pharmacists, potentially due to lack of awareness or perceived benefit.

Top Issues this Workgroup could Address

1

Overcoming technical challenges for pharmacists to engage in clinical interoperability with other care team members

2

Identifying and operationalizing the information pharmacists need to access and share with other providers and payers

3

Characterizing the benefits of pharmacy interoperability for all stakeholders – especially the economic benefits

Top Ideas for Workgroup Deliverables



Roadmap / Implementation Guide
for pharmacy interoperability that depicts the current ecosystem and key steps to close gaps in readiness and adoption



Education
of industry stakeholders and policymakers about the role pharmacists play on patient care teams and the importance of pharmacy interoperability



Pharmacy Use Case
that supports pharmacy interoperability, aligns with pharmacy patient care services, and defines what data pharmacies need from others and what data others need from them



Economic Analysis
that captures the cost/benefit of pharmacy interoperability for all stakeholders



Inventory
of existing legislative and regulatory policy for pharmacy patient care services and identify potential pathways for advancing pharmacy interoperability

NOTE: The Steering Committee will evaluate these ideas and propose deliverable/s at the Workgroup kickoff. Importantly, some of these ideas may present opportunities for parallel initiatives.

Potential Workgroup Inputs

What inputs are needed for the workgroup to be successful?

- Consumer groups, system vendors, pharmacy end users, health plans, ASTP, and CMS.
- The physician perspective on how exchanging information with a pharmacist would make a difference for them.
- Workflow analysis which outlines how data is accessed in a medical environment vs. pharmacy workflow.

Next Steps

- The Steering Committee will use findings from listening sessions to develop a Workgroup charter.
- Listening session participants are invited to become a Sequoia Project Member and join the Pharmacy Workgroup.
- The Pharmacy Workgroup is scheduled to launch in **December 2024** and will meet **monthly in 2025**.
